Truist Championship

The Birdies for Better program invites local nonprofits to leverage the excitement of the Truist Championship to raise funds for their organizations.

HOW IT WORKS

DATES: The program runs from November 12, 2025 through May 6, 2026.

PLEDGE & GUESS: Participants who elect to enter via this donation form pledge to donate at least \$20 to the participating charity of their choice. A participant must guess the total number of birdies made by PGA TOUR players during the competitive rounds of the Truist Championship (May 7 – May 10, 2026).

EXCLUSIVE PRIZES: One lucky supporter who comes closest to guessing the total number of birdies made during the tournament will win a one year Audi Q5 lease or \$10,000. Our runner-up will win a VIP Experience for Two at the 2027 Truist Championship.

TIEBREAKER: If there is a tie, the winner will be determined by the most accurate guess to a tiebreaker question: How many balls will land in the water on the Green Mile stretch (Holes 16, 17 & 18)? If multiple ties remain, an additional tiebreaker question will be used to determine the winner: How many balls will land in the water at Hole 18?

BONUS POOL: The tournament has contributed funds to a bonus pool totaling \$100,000 that will be distributed among participating charities based on their fundraising efforts.
